### **Sub: Nomination of Pushpanjali Crosslay Hospital, Vaishali, Gaziabad**

#### **1.0 Proposal**

A proposal has been received bearing Ref.No.UPSO-II/ HR/ Medical dt.26.3.2010 and duly recommended by G.M.I/C (RS) NR. for empanelment of Pushpanjali Crosslay Hospital, Vaishali, Gaziabad. **(F/A)**.

#### **2.0 Background**

**2.1** At present, IOC have nominated only one hospital viz.Yashoda Hospitals, Kaushambi at Gaziabad. Pushpanjali Crosslay Hospital is situated in Indrapuram, Dist.Gaziabad. The location of the hospital shall cover employees staying at Indrapuram, Vasundhara, Mayur Vihar Ph-II and III and other nearby areas. Approx.150 employees/ex employees will be benefited by nomination of the subject hospital. There is also a persistent demand from the employees,residing at Gaziabad for nomination of subject hospital. Therefore,a Committee was formed consisting of Shri Rakesh Arya,Sr.Mgr.(LPG-O),Shri Arvind Kumar,Mgr.(F),Shri GN Pant, Dy.Mgr.(HR) UPSO-II and Dr.Leela Rajan,IOC Panel Doctor, who visited the subject hospital on 25.1.2010 ,inspected the facilities and has recommended nomination of the hospital **(F/B)**.

#### **3.0 About the hospital**

**3.1** Pushpanjali Crosslay Hospital is a 470 bedded hospital ( at present 210 beds in operational conditions) – a multi Specility tertiary care hospital situated at Vaishali bordering Gaziabad and Delhi. This hospital is North India's best Galaxy Cancer Institute, Centre of Excellence in Aesthetic Surgery, dedicated Cardiology, and Cardiothoracic surgery wing, Trauma Centre, Heliambulance, besides all medical services, thus making it one of the Best and Biggest healthcare facility in this part of the world. The hospital offers 15% discount on IPD, 20% discount on OPD.

**3.2** The Hospital possesses a valid Income Tax Exemption Certificate under Sub-clause (ii) of the proviso to sub-clause (vi) of clause (2) of Section 17 of the Income Tax Act 1961 reads with Rule 3A(1) and 3A(2) of the Income Tax Rules 1962. valid upto 30.6.2012 **(F/C)**.

3.3 The bed charges offered by the hospital are competitive and can accommodate all categories of employees.(F/D).The Health check-up rates offered, are higher than Sir Ganga Ram hospital at Delhi,hence,the Committee Members recommended nomination of the subject hospital except Health check-up.

#### 4.0 Recommendation

It is proposed to recommend nomination of Pushpanjali Crosslay Hospital, Vaishali, Gaziabad,(except Health check-up) in view of the following :

- 4.1 The hospital is located near IOC employees staying at Indrapuram, Vasundhara, Mayur Vihar Ph.II & III areas. There is a demand from the employees for nomination of subject hospital.
- 4.2 The hospital possesses a valid Income Tax Exemption Certificate.
- 4.3 The bed charges are reasonable and can accommodate all categories of employees.
